

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.traveladventuresandtours.com](http://www.traveladventuresandtours.com), and Travel Adventures and Tours and governs data collection and usage. ## Collection of your Personal Information

- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our
